About accommodation fee in university dormitories for applicants, undergraduate, graduateand postgraduate students

According to the article 39 of the Federal Law "About Education in the Russian Federation" from 29.12.2012 №273-FZ, position of Minin university dormitories' student councils and in accordance with financial calculations of accommodation fees it is ordered:

- 1. To establish accommodation fee in Minin university dormitories for state-funded cohorts (Appendix 1):
 - 1.1. Accommodation fee for students (undergraduate, graduate, postgraduate students) undergoing full-time studies on main educational programs of secondary vocational and higher education (dormitories № 1, 2, 3) is 503,00 RUB per month.
 - 1.2. Accommodation fee (for the examination period) for students (undergraduate, graduate, postgraduate students) undergoing correspondence studies on main educational programs of secondary vocational and higher education (dormitories № 1, 2, 3) is 17,00 RUB per day.
- 2. To establish accommodation fee in Minin university dormitories for students undergoing studies with full cost recovery (Appendix 1):
 - 2.1. Accommodation fee for students (undergraduate, graduate, postgraduate students) undergoing full-time studies on main educational programs of secondary vocational and higher education:

Dormitory $N_{2}1 - 651,00$ RUB per month;

Dormitory N_{2} – 520,00 RUB per month;

Dormitory $N_{\odot}3 - 503,00$ RUB per month.

2.2. Accommodation fee (for the examination period) for students (undergraduate, graduate, postgraduate students) undergoing correspondence studies on main educational programs of secondary vocational and higher education:

Dormitory $N_{2}1 - 22,00$ RUB per per day;

Dormitory No2 - 17,00 RUB per per day;

Dormitory $N_{2}3 - 17,00$ RUB per per day.


- 3. To establish accommodation fee in Minin university dormitories (the cost of public utilities) in the amount of 447,00 RUB per month for students:
 - who have the right to receive state social care;

- who belong to citizens who have been doing contract military service for at least three years in military positions to be replaced by soldiers, sailors, sergeants, sergeant-majors and those who was dismissed from military service on grounds written in paragraph 1 (subparagraphs "b"-"d"), paragraph 2 (subparagraph "a") and paragraph 3 (subparagraph "a" "c") of the article 51 of the Federal law "About conscription and military service" №53-FZ from March 28, 1998;
- single mothers with children of minority age.
- 4. To establish accommodation fee in Minin university dormitories for applicants for the period of entrance exams (Appendix 1) in the amount of 170,00 RUB per day including a 20% value added tax (VAT) in the amount of 28,33 RUB.
- 5. No accommodation fee (rent and public utilities) in Minin university dormitories is charged from the following students:
 - Orphans and children left without parental care;
 - Persons from among orphans and children left without parental care;
 - Children with disabilities, people with disabilities of 1st and 2nd groups, persons with lifelong disabilities;
 - Students who were exposed to radiation due to the Chernobyl Nuclear Power Plant disaster and other radiation disasters that occurred because of nuclear weapons testing in the Semipalatinsk test site;
 - People who got disabilities as a result of military traumas or diseases received during military service; military veterans.
- 6. Accommodation fee for each semester must be paid within first two weeks after its start:
 - 1st semester 5 months (September January);
 - 2nd semester − 5 months (February − June).
 - 6.1. Payment during the period of summer holidays (July, August), provided that the student does not live in the dormitory at the given moment, must be charged in the amount of the rental fee (Appendix 1).
- 7. In case a student doesn't pay accommodation fee within two months after beginning of the semester, he/ she will be brought to disciplinary responsibility up to eviction from the university dormitory with the subsequent payment of the debt.
- 8. University dormitories' managers and headmen of student councils in dormitories №1, 2, 3 must inform all residents about the abovementioned information of the order.
- 9. The following stuff members and departments shall be charged with supervising the execution of this order and timeliness of accommodation fee payment: chief accountant, head of the student dormitory complex, managers of dormitories №1, 2, 3, chairmen of dormitories' student councils, head of the international education and cooperation department, head of the foreign citizens' affairs division.
